THANKSGIVING AT PLYMOUTH

In September 1620, a small ship called the Mayflower left Plymouth, England, carrying 102 passengers—an assortment of religious separatists seeking a new home where they could freely practice their faith and other individuals lured by the promise of prosperity and land ownership in the "New World." After a treacherous and uncomfortable crossing that lasted 66 days, they dropped anchor near the tip of Cape Cod, far north of their intended destination at the mouth of the Hudson River. One month later, the Mayflower crossed Massachusetts Bay, where the Pilgrims, as they are now commonly known, began the work of establishing a village at Plymouth.

MINUTES

RETIRED PUBLIC EMPLOYEES' ASSOCIATION - CHAPTER 035

The quarterly meeting of Chapter 035 of the Retired Public Employees' Association was held on **August 9**, **2023**, at the Vallejo Moose Lodge.

The meeting was called to order by President Rachel Maldonado Aziminia at 12:52 p.m. Nineteen members and guests were present. All Officers and Directors were present except for Communications Director, Mary Cecchini and Newsletter Editor Lotte Sather.

President Rachel Maldonado Aziminia led the Pledge of Allegiance and introduced member, Bob Hepner and his guest Connie Tapp. She also introduced first time attendees, Wayne Johnson and Carrie Hubbard from Napa, and Charles Kitts from Fairfield. She announced that today's luncheon and the luncheon at our November meeting will be free. Rachel will be contacting the Solano Community College Music Department to see if they would be able to perform at our November meeting.

Our first guest speaker was Loran Vetter, Chair of the RPEA volunteer committee. She writes a column in our RPEA Newsletter trying to explain the importance of volunteering. There is a misconception that public employment retirees don't deserve their pension because they didn't work hard enough for it. In order to change public opinion and the opinion of our legislators, we need to show how much we're putting back into the community. She is keeping a list of where our members are volunteering and how many hours they are putting in. The Federal Government has established a value of \$37.32 for every hour that we volunteer. Using that figure, less than 1% of our RPEA members have reported \$1,953,000.00 worth of volunteer time to her. Our second speaker was Elena Yuasa, Director of Membership for RPEA. She talked about recruiting new members by letting them know that RPEA does a lot of work behind the scenes to protect our pensions and health benefits. There is a Legislative Committee that reviews all the bills that affect retirees. We need to talk about RPEA to let potential members know what to expect. To retain members, we need to listen to them to see what their needs are. She suggested one way to recruit was to send a link to RPEA's website to show all the work that is being done on our behalf.

President Rachel Maldonado Aziminia reported that she was invited to attend a CalPERS Benefits Education event in Eureka on behalf of RPEA.

The minutes of the May 17, 2023, Quarterly Meeting were approved as posted in the Newsletter.

Treasurer Patricia McCarthy reported that our beginning balance for this past quarter was \$26,604.87. We had income of \$1,433.80 and expenses of \$1,029.73, leaving an ending balance as of the end of July of \$27,008.94.

Membership Director Marlies Lenigk reported that we currently have 503 members.

Health & Welfare Director Odessa Pinnock reported that she sent Get Well cards to Dorothy Hays, Lynn Ancheta and Shirley Dingley.

Old Business: Copies of the proposed bylaws changes were handed out to all members present. President Rachel Maldonado Aziminia pointed out that the new language was in red, and a strike out indicated the old language. Jim Anderson, Chair of the state Bylaws Committee provided a template for what our bylaws should be like. If you have any questions, you can text, email, or call Rachel. We will vote on the proposed changes at our November meeting.

New Business:

President Rachel Maldonado Aziminia suggested that we create a committee to discuss 1-day outings for our members, such as to a winery, or to the theater or the movies. Eleana Yuasa suggested that we consider partnering with our local Senior Center. Membership Director Marlies Lenigk volunteered to contact them to see what is available.

Our luncheon today was free. In November, our holiday luncheon will also be free. The Board will be discussing what to charge for future meals at their next meeting. If you have an opinion on how much should be charged, please contact Rachel and let her know.

The next Quarterly Meeting will be on November 8, 2023.

The meeting adjourned at 1:52 p.m.
