#### Message From the Treasurer--

The CalPERS Board's Agendas are always posted on the CalPERS website. The Board Meetings are transmitted online, live to anyone who wants to watch. This past week I watched a portion of the CalPERS Board meeting on March 20, 2024. At that meeting, the Board passed a Resolution to oppose an initiative that recently qualified for the California General Election Ballot to be held November 05, 2024. It is presently referred to as, *The Taxpayer Protection and Government Accountability Act*.

In addition to testimony presented by several members of the Board, there were several speakers present from various public entities and public employee unions. All voiced opposition to the Initiative that, if passed, will require an amendment to the CA Constitution, and severely limit funding for public pensions.

I urge all members of Chapter 044 to become active in learning about the pros and cons of this upcoming ballot measure and **VOTE** in the CA General Election November 05, 2024.


