HR 82 Gets Late Night Vote and Passes Senate

SACRAMENTO – RPEA Legislative Director, Randall Cheek, released the following statement after the Senate voted to repeal the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP):

The Social Security Fairness Act was passed by the United States Senate at 12:04 A.M. today, December 21, 2024, on a bipartisan vote of 76 to 20 with 4 not voting. Only Republicans voted no. The four not voting were Manchin of West Virginia, Rubio of Florida, Vance of Ohio and Schiff of California. The bill will repeal 42 years of the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO).

This significant victory for public service workers is the culmination of persistent advocacy and unwavering determination. For years, members of the Retired Public Employees' Association of California (RPEA) have tirelessly campaigned to eliminate the inequities imposed by the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), which unjustly deprived certain public service workers of their entitled Social Security benefits. Through Senator Sherrod Brown's steadfast, decade-long commitment to repealing these provisions, and the concerted efforts of a broad coalition of retiree associations and union members, over two million public service workers will now receive the Social Security benefits they have diligently earned throughout their careers. Many can finally anticipate a well-deserved retirement after a lifetime of service. We commend the Senate for passing the Social Security Fairness Act and urge President Biden to promptly enact this bill into law.
