



#### PROTECT YOURSELF FROM SCAMMERS

It seems this is the season for the scammers to really hit us with robo-calls and other attempts to get to our finances. Be aware that Social Security, the IRS and other government agencies will NOT attempt to reach you by phone. Don't trust your caller ID: Scammers can make it look as if the Social Security Administration is calling and even use the agency's real number.

Don't give out personal information. Never give out your Social Security number, your Medi-care number, your bank information or other personal details to an unknown caller. If you alread did, visit IdentityTheft.gov/SSA to find out what steps you can take to protect your credit and your identity. Don't trust the caller just because they may know some of your personal information: It's most likely a scam if the person on the other end asks to confirm your information. Talk about the experience: Those who've been targeted should alert friends and neighbors about the call to spread information and report the scam to the FTC at FTC.gov/complaint.



# NON-PERISHABLE FOODS, YOUR USED GREETING CARDS AND/OR PULL TABS FROM ALUMINUM CANS

Please bring non-perishable food to donate to the Sacramento Food Bank when you come to any meeting or member luncheon. Just one can a meeting can make a big difference to a local family. We have successfully donated to the Food Bank every year.

And did you know we can make a difference with items we usually toss away?

Don't toss your used greeting cards! Bring only the fronts of the cards to the Chapter meeting for me to get them to St. Judes's Ranch for Children. The program assists young people in learning business skills while raising funds for a charity. Rather than toss those aluminum tabs from soda cans and other products that use them, bring the tabs to the meeting and I will get them to McDonald House, which collects them as a fund-raiser for their programs.

#### SACRAMENTO CHAPTER 4 BIENNIAL ELECTION

Election of Chapter Officers, Directors at Large and Delegates to RPEA's General Assembly will be held at the February 12, 2020 Chapter meeting at Casa Gardens Restaurant, 2760 Sutterville Road, Sacramento. Only Chapter members in attendance will be eligible to vote.

The four elected Officers, the six elected Directors at Large receiving the highest number of votes, the Past President and six appointed Standing Committee Chairs will constitute the Chapter's new Board of Directors. The Board carries out the policies and business of the Chapter and its newly elected officers shall be installed and assume their duties at the February meeting.

The President and candidates receiving the highest number of Delegate votes become the Chapter's Delegates to RPEA's General Assembly. They must attend all General Assembly meetings and will also vote on the Business of General Assembly when in session. It is Chapter 4's policy to take the next two candidates with the highest number of votes to General Assembly as Alternate Delegates at Chapter expense.

If you are interested in being a candidate for any Chapter Officer position or a Director at Large and/or a Delegate to General Assembly, be sure to so indicate by a (X) on the following Consent Form. Your completed Consent Form must be received by the deadline noted.

Nominations will be accepted from the floor at the February 12<sup>th</sup> meeting.

Note: California State Retirees has recently changed its Governing Rules. They now state that to remain a Member in Good Standing a member may not be "simultaneously holding a CSR office and an office within a competing organization". According to Tim Behrens, President of CSR, RPEA is a competing organization. If any of our members hold an office in CSR and wish to run for a position within our Chapter, they may need to resign their position in CSR if they do not want to jeopardize their standing in CSR. Those who have benefits such as vision or dental insurance that they obtained as a member of CSR could lose those benefits if they are deemed a member not in good standing.
