<u>Recaps from last meeting.</u> Joining us from the downtown fire station in Salinas were the team of Captain Robert Marx, an Engineer, one Firefighter, and a Paramedic. There are six stations around the city, a city that encompasses 55 sq. miles. The fire department is the first responder to 911 calls.

Recently, the city was charging for emergency services from the fire department; however, Captain Marx indicated that this matter has been settled. There is no longer a charge for calling the fire department. So please do not hesitate and make that call when faced with an emergency.

All fire stations regardless of city, respond to all areas outside their districts if the need arises. In case of a catastrophic emergency a firefighting team from each district goes out into neighborhoods within their jurisdiction to patrol for infrastructure damage. Utility companies are contacted when power lines are down and water leakage noted. Further, we are reminded to never go near a downed power line or into water damaged areas. Call 911!

We were also given important tips on how to prepare for an emergency, such as a fire or other types of structural damage to our homes. See helpful tips below:

- Keep photos ready to go

- Important documents
- -
- Change of clothes (3-5 days)
- Drinking water in trunk of car (change periodically [for freshness] as needed)
- Medications
- Flashlights & batteries
- Food
- Phones and chargers (Be aware that phone lines and cell tower may be down)

We were so grateful that this team of firefighters were able to join us and give us valuable information that we can all use in times of disaster. They were all so kind and caring that we truly respect the job they do to keep us safe wherever we live.

The Big Truck! Here is a little story that I hope you enjoy. One of our members (our immediate past president) shared with us a story about an emergency situation that occurred during her grandchild's birthday. Susan's mother fell ill and required services from the fire department. They were called and within minutes drove up in their great BIG red fire truck whereupon all the children ran up thinking it had arrived for them. Well, great-grandma got her care and was safe, but the kids got the biggest treat of all – the presence of the **big red fire truck** in in the front yard and in visiting with the firefighters who were so kind to them.
