ATTENTION: CaIPERS DIRECT DEPOSIT RECIPIENTS

Members who receive their CalPERS monthly allowance by direct deposit should be aware that this year December 31 falls on a Thursday. This makes Friday, January 1, 2021, a holiday. As a result, banks and credit unions will be closed and your direct deposit **will not** post in your account until Monday, January 4. If you have auto-pay payments scheduled to pay on the first day of the month, there **may** be insufficient funds until January 4. This could cause an overdraft situation for you.

CalPERS News, continued:

Dependent Reverification for State and CSU Members (Insurance Eligibility)

In January 2021, CalPERS will begin the second three-year cycle of the dependent reverification process. The dependent reverification process requires all active and retired state and California State University (CSU) employees to verify their dependents meet the eligibility requirements for continued CalPERS health and/or dental benefits every three years. Members will receive the first dependent reverification letter 90 days before their birth month. The letter will provide a list of dependents who members are required to verify along with important information and instructions. All verification documents are due by the first of the member's birth month. If documentation is not provided by the due date, the member's dependent(s) will be removed <u>automatically</u> from their health and/or dental benefits.

Dependents who require verification:

- Spouses
- Registered Domestic Partners
- Natural Born Children*

- Adopted children*
- Stepchildren
- Children of Registered Domestic Partners

State and CSU Retirees: Once a member retires, they will have to resubmit all reverification documents to CalPERS during their first reverification cycle as a retiree. To ensure secure and timely processing of a member's reverification documents, members may upload their signed and dated Dependent Eligibility Verification Affidavit and all other required documents online by logging in to myCalPERS and going to the **Health** tab and selecting the **Verify Your Dependents Now** link. Processing can take up to 30 days and you will receive a notification letter.

All of a member's required dependent reverification documents submitted as a retiree will be retained by CalPERS. Members may not be required to provide the government issued marriage certificate, domestic partnership registration, and birth certificates for stepchildren or domestic partner children if the marriage or domestic partnership remains current.
