

GENERAL MEETING LUNCHES

At our December Chapter meeting, members were served full sized meals (versus senior size) Courtesy of Awful Annie's. At the time, this seemed like a nice holiday treat. This year, at our February Meeting, we were again served full sized meals rather than the "Senior size" that had been served in the past. This is now the new normal. In January 2019, Awful Annie's raised the price of the meals by one dollar from \$16 to \$17. With the pricing change, the restaurant also did away with the "Senior" size versus "full" size meal structure. Now that Awful Annie's is only serving the full sized meal, at one easy Price, we no longer have to identify which people gets the pricier meal. Now the servers no longer have to look for those white cards that said FULL, in order to serve lunch. Chapter members will continue to pay \$12 per **meal**; however, the price of a guest lunch has gone up to \$17.
