

In 1984 I took a part-time job with a small local company. Then in 1988 I was hired as a clerk typist, extra help at the Placer County Welfare Department. At the time I started working at Welfare it was a stand-alone department; however, in 1995 when Welfare merged with Health to become Health & Human Services, I had an opportunity to move around within a very large department. Through my 20 years employment at Placer County I worked within every division of HHS.

I officially retired in 2008 from HHS Administration, but returned for three additional years as extra help. In 2011 I officially joined my husband in retirement. As retirees we travel as much as we can, but we don't get a chance to do much sailing anymore. We have a travel trailer for short trips and when we are home we spend lots of time working on our house and getting together with our three grandchildren.

(Bob was there! But someone had to take the picture!)

Bob and I took a short vacation, to Eureka California where we lived for a few years, in the early 60's. Bob worked as a telegraph operator for the Northwestern Pacific Railroad until the flood of 1964. The railroad was completely destroyed. Our Daughter, Klaudia was just born and was only 5 weeks old when we left Eureka and headed back to Fresno. The damage was so bad the the railroad was not expected to ever operate again. However, Bob was called back in August of 1965.

Needless to say, after not seeing **Eureka** for 30 years, nothing looked familiar to us. We didn't think we had to bring addresses of our old homes there, but we should have. We couldn't recognize either one of them. So much traffic and new construction going on.

The high light of our trip was meeting the President of the **North Coast Redwoods RPEA**,

**Deann McCall**. Our President, **Joan Gates**, had connected with her at a seminar or two. **Deann** lives in a small community, east of Eureka, called **Cutten**. **Eureka**, **Humboldt County**. **Deann** went to work for the Court System, right out of high school and worked there for 37 years. Her husband is a logger and she has a daughter who lives in **Rocklin**, **California**. The **Crescent City** Chapter closed in **January**, and about 30 members joined **Chapter 024**. It is a 100 mile drive, down Highway 101, to **Eureka**. They have about 25 members who attend the lunch/meetings. The meetings are held at the **Samoa Cook House**. We ate there and it's good. At one time, **Deann** was the President, Secretary, Treasurer and Newsletter editor. Their membership is about like ours, 250 members.

Our trip started off a little unnerving. After driving a 100 miles on Highway 36 from **Red Bluff**, we were stopped, just past **Dinsmore**. The road was closed ahead, for bridge construction. We would have to go back and go around. Or, we could take **Forest Service Road 1**, across the mountains to Highway 299. It would be a 60 mile trip (over 3 hours) through old burned-out trees still standing, white and ghost-like. We never saw another car until we were about 10 miles or so from Highway 299. The best we could do was drive between 25 and 35 miles per hour, and still miss the many pot holes, swerving around the ones he could see. We hit one that should have blown a tire. It wasn't until we got home that he discovered the tire jack was left behind in the garage. He said he didn't want to get caught out there after dark. I kept telling him that this road had to eventually come out somewhere. We did see 4 or 5 white-faced, black steers. **Bob** said he wished they could tell him where he was. He did stop and took their picture. After a couple of hours, a pickup truck did pass us. Later, we saw another and was able to flag him down. He said we were maybe 10 or 15 miles from highway 299. The road smoothed out the closer we got to the highway; and of course, we hit the 5:00pm traffic in Eureka.
