### **NOTES FROM THE APRIL BOARD AND MEMBERSHIP MEETINGS**

Our Chapter Board met via Zoom the morning of April 27. Here are some highlights of the meeting:

- We received a thank you card from the family of a deceased member, grateful for our contribution to the RPEA Building Fund in memoriam.
- Three members have volunteered to help out with our September picnic!
- The Volunteer of the Year Committee will meet and select a Volunteer of the Year.

Our Chapter Membership meeting met via Zoom the afternoon of April 27:

- Rhonda Schmidt, SCC Benefits Director, gave her annual presentation.
- Treasurer's Report: We have \$26,876 in checking and \$31,536 in our C.D. Expenses have been the newsletter, storage shed, and contributions to the Building Fund in memory of deceased members.
- Courtesy Report: Over the past three months we have had 24 deaths. If you know of a member who is ill and would appreciate a get-well card, please notify Sue Farr.
- Membership Report: we have 2,126 members, no new members.
- Elks Lodge remains closed for upgrades, so we will continue to meet via Zoom.
- If you would like to nominate someone for the Volunteer of the Year award, please contact Sue Farr. Her committee will meet on May 2 to make a decision.
- If you would like to help with our picnic in September, please contact Kathy Miller. There will be a planning meeting on June 9.
- Rosemary Knox, a member of our Chapter and President of RPEA, was present and reminded us that there will be a special election for a retiree on the CalPERS Board; only retirees can vote for this seat, so please remember to vote! The voting will be held August 26-September 26. We will be getting more information on the candidates from both RPEA and CalPERS.
- Randall Cheek, RPEA Director of Legislation, was present and gave some legislative updates.
- We had 52 participants at our meeting!

### Exploring Guadalupe River Park

In continuing our river journey, your editor Mary Mitchell and I took a trip to downtown San Jose. After driving along its length, we realized that we would be making several trips to report on all of the features of this urban park.

Our first visit was to the Rotary PlayGarden: [Rotary PlayGarden – Guadalupe River Park Conservancy \(grpg.org\)](http://grpg.org) Mary and I arrived on a weekday just before their opening time of 10 am.

There is plenty of parking. We observed staff wiping down play surfaces and tending to the plantings. When we entered through the gate, we were amazed. This playground is designed for all children to use and enjoy. Every feature has been carefully thought out and designs and artwork speak to our local ecology. This is a lovely place to bring the children in your life, or to visit even if you don't bring any children. There are multiple levels with a gradually sloping ramp-path to loop you up to the top and down again.

There is a bathroom and picnic tables inside the enclosed play area. Looking out of the playground, you can sight the Historic Orchard and the Heritage Rose Garden.

Check the website before you go, as days and hours have changed. Also, check to see if picnicking inside the play area is allowed yet; it has been restricted due to Covid.

The Visitor and Education Center is adjacent to the playground and, although small, is definitely worth a visit to see some critters and a beautiful mural. Ring the bell and you will most likely receive a personalized tour. Of special interest are two terrariums set up to be self-sustaining environments.

Next, we used the walking path just outside of the playground to walk over to the orchard and the rose garden. We noticed it was best to use walking paths when available instead of the pedestrian & bike paths, as many bike riders tend to go very fast. We passed by a handful of temporary campsites of people living in the park. The orchard is being rehabilitated and replanted with fruiting trees that tell the story of orcharding during the heyday when we were known as The Valley of Heart's Delight. The rose garden has more varieties than any other public garden in the Western Hemisphere. The weeds and ground squirrels have taken their toll on the garden, and the area needs some tender loving care (and hard work!), but it is well worth seeing when the roses are in bloom. We noticed that this area abounds with birds and birdsong, and we were especially excited to watch a pair of red-tailed hawks build a nest up in a eucalyptus tree near the Play Garden. Not having a picnic lunch, we crossed Coleman Street to the San Jose Market Center and had a selection of a few restaurants with outdoor seating. We decided our next outing will be the "top end" of Guadalupe River Park, anchored by the Children's Discovery Museum. Until next month...

**R**honda Schmidt, our Employee Benefits Director, gave a presentation to our membership at our quarterly April meeting. She had some really good news to share with us.

**First**, she has reorganized the Benefit Representatives by separating current employees from retirees. These four reps will only handle retirees:

**Second**, executive retirees now have the same rates as non-executive retirees. This has already gone into effect, so we will no longer have two separate rate schedules.

**Third**, this year she has good rate changes to share with us! For example, Kaiser Senior Advantage has a 2.32% decrease and Health Net MCare has no change.
