And we welcome Margaret Brown who RPEA elected to the Board of CalPERS. as a new Assistant Area Director for Area VIII.


I look forward to seeing you at the General Meeting on March 13, 11:00 am at the HomeTown Buffet Santa Ana, and bring a guest and or prospective member.

#### MINUTES OF GENERAL MEETING RPEA Chapter 040, December 12, 2018

The regular quarterly meeting of RPEA Chapter 040 was called to order by President Ivory Webb at 11:55 am. In attendance were CalPERS board member Margaret Brown (featured speaker), Area VIII Director Kathleen Collins, and new member Carolyn Ikei.

**Minutes:** The minutes of the general meeting of September 19, 2018, and the minutes of the board meeting of October 10, 2018, were read by Secretary Mercedes Smith. Current and new employees can possibly have less retirement due to changes in CalPERS rules. And many have been affected by health care changes. Fiona Ma is the new CA State Treasurer. Jason Perez, a Corona Police Department Sergeant and police association president, is the newest member of the CalPERS board. The new board members (7 out of 13) believe the money is for the benefit of all members and are questioning how money is spent. This is good for transparency, accountability, and returns.

**New Business:** President Webb advised that as an organization we cannot donate to disaster victims (such as the California fire victims). However, individuals can donate.

The slate of officers for the 2019 & 2020 board of RPEA Chapter 040 are: Ivory Webb, President; Estela Pena Merkosky, Vice-President; John Jago, Treasurer; and Mercedes Smith, Secretary. Viola Sadler moved that this slate be accepted by acclamation. MSP. AD Collins installed the new officers.




