During the meeting, CalPERS board member Margaret Brown briefed attendees on legislative affairs in Sacramento. Rest assured, she and fellow CalPERS board member Jason Perez have been working diligently to protect *your* pension and benefits—despite the fact that everything has been virtual over the past 14 months.

One continuing area of concern is AB 386. This bill would allow CaIPERS to loan trust fund money without disclosing the borrower's ownership, loan terms or, any collateral pledged. RPEA Board Vice President AI Darby wrote an excellent article on this in the March/April RPEA newsletter. Stay informed, and let your voice be heard.

"Our study is the first to provide large-scale quantitative evidence of the medical adage that the first place to look for dementia is in the checkbook," says Dr. Lauren Nicholas of Johns Hopkins University. "Earlier screening and detection, combined with financial education, are important to protect the financial well-being of the patient and their families."

They were also more likely to have their credit scores drop below 620 (called

"subprime"). This started two and a half years before getting their diagnosis.
