## RPEA Actions Help to Restore Portion of Pension Benefits

The case involves a small joint powers authority in the San Gabriel Valley, but the ramifications strike a responsive chord in RPEA chapters throughout California. The East San Gabriel Human Resources Consortium (also known as LA Works) stopped paying its prescribed pension allocation to CalPERS some months ago when the agency folded. CalPERS then cut the agency's retiree benefits by nearly two-thirds.

RPEA vigorously supported AB1912, which forbids member agencies of a joint powers authority to stop paying retiree pensions when (a) the retiree agreement with CalPERS is terminated or (b) the JPA stops operating or simply dissolves.

But this bill addresses future situations, not the LA Works problem. So RPEA joined the effort to have pension benefits restored to the retirees who had seen a huge share of their benefits disappear. And just days ago CalPERS reestablished a portion of the lost benefits. Not a big share, but a start.

RPEA's state president, Al Darby (elected to that post at the September General Assembly meeting), praised CalPERS for taking this step, but also noted that the ultimate goal should be total restoration of the benefits. Darby said, "RPEA will continue to work with CalPERS and the Legislature to fully restore the benefits that were so drastically cut as a result of the dissolution of the joint powers authority."

What does that have to do with Chapter 084? Everything. I bring you this story as a real-world indication of RPEA in action. We don't just say we're here to protect your benefits; we actively and aggressively work to do so. And that dedication starts at the top.

We've often noted that you need RPEA precisely because it's a firewall between you and potential erosion of benefits.
