Meeting Adjourned at 12:34 pm

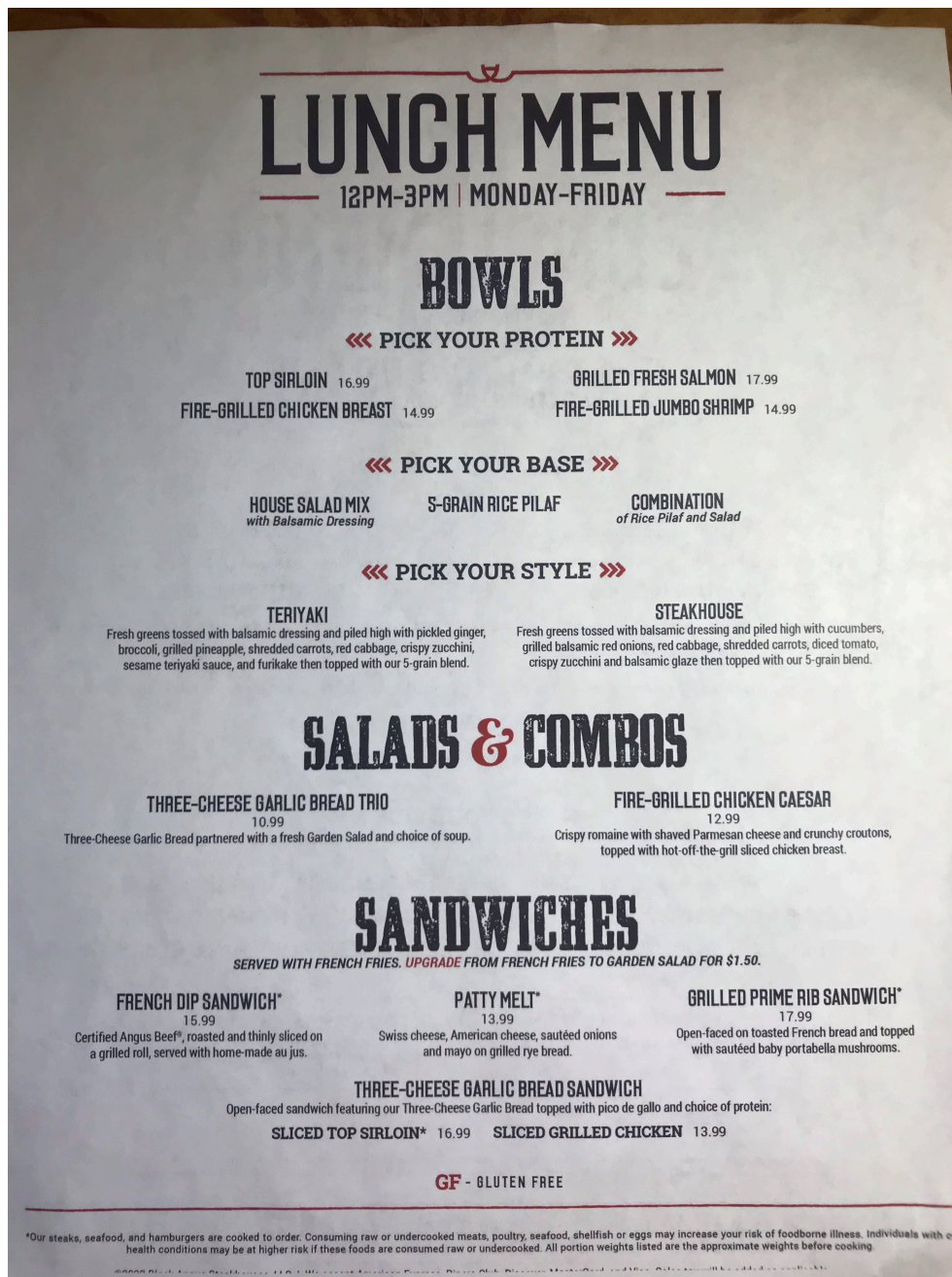
