Hi Everyone! I'm back from the land down under and look forward to our next meeting on Thursday, May 16, 2019. Lunch is provided at a cost to our member guests of \$5. Our lunch speaker is Harriet H. Roland, Esq. Her areas of practice include Elder Law and Estate Planning.

As most of you already know, the RPEA Board endorsed JJ Jelincic for the Retiree Seat on the CalPERS Board. He needs 500 signatures of any CalPERS retirees by May 10, 2019 to meet the deadline for signature submission. Other retiree associations will be helping with this effort, but we need to get as many signatures for JJ as possible. JJ

has been an asset on our behalf over the years and has even been a speaker at our chapter in the past. Please contact RPEA on their website.

We had slightly better attendance at our last meeting. I would appreciate any ideas and input from you on possible speakers at future meetings or if you have something interesting to speak on at a future meeting. We need to be informed and proactive about issues facing our pensions, Social Security and Medicare entitlements.

With the loss of two of our Board members, we need more people on the Board. If you are interested in being an active part of the chapter, please let me know. It doesn't take much time, only a few hours every few months, as we usually have a short meeting prior to our lunch meeting and we only meet a few times a year. Fall 2020 is the next RPEA General Assembly and we will want representation there. Last year only one person from our chapter was able to attend and it was a very informative event. We hope to be able to have at least one more member there in 2020.

UPCOMING MEETING DATES

We will be discussing upcoming meeting dates at our board meeting May 16 and welcome suggestions for alternative dates and locations. Many places require a minimum number of lunches. Our next meeting will be sometime in September.

TREASURER'S REPORT

The balance in our Chapter 99 Bank Account on December 31, 2018 was \$1,547.45, on January 31, 2019 was \$1,542.33, on February 28, 2019 was \$1,747.68, and on March 31, 2019 was \$1,911.43. Expenses for the January luncheon were \$214.17, mailings were \$209.38 and a service fee of \$14.00 was charged monthly. Our only source of income was a portion of dues sent by RPEA. This included \$211.85 for December, \$223.25 for January, \$221.35 for February and \$175.75 for March.

PRESIDENT'S BUDGET PLAN

The Committee to Preserve and Protect Social Security sent an alert about the President's Budget and its effect on retirees as follows:

"No one serious about protecting Social Security, Medicare and Medicaid would propose a budget so harmful to older Americans that includes: Slashing \$845 billion from Medicare over 10 years; gutting Medicaid with a proposed \$1.5 trillion in cuts over 10 years, which undermines seniors' access to long-term care services; cutting Social Security by \$47 billion over 10 years; cutting block grant funding for vital Meals on Wheels programs, which deliver 2 million hot meals to seniors each year; and eliminating programs that help lower-income adults get community service jobs and help seniors with heating costs." Please let your Senators and Representatives know how you feel.

SCAMMERS

In a recent AARP newsletter, they reported on ways scammers get your personal information, including phone numbers, addresses, etc. When you send in warranty information and list your household income, or enter contests, or fill out survey questionnaires, or rate hotels and restaurants, or disclose your location on facebook, some of this information can be sold to other

companies or accessed for other purposes. Information in obituaries are targets for scammers and mail thrown away without being shredded can be accessed. Marketing firms pay a lot of money to acquire information from other sources. In addition, public records can be accessed in various cities, counties, and states for use in mailing or telephone solicitations. Be careful when disclosing any information to others.

While we encourage participation in one of our many chapters, most of our members participate by reading RPEA's bi-monthly newsletter, giving us feedback on their needs, and enrolling in one or more of our "members only" insurance programs.

At \$5.00 per month, RPEA is a bargain hard to resist. We need you and you need us — to support our fight to protect our pensions and benefits.
