Okay, so sometimes my facts are not 100% accurate - - the Alliance for Retired Americans (which focuses on Medicare and Social Security) is one of the several coalition organizations standing side-by-side with RPEA to benefit the retired in America.

In our home State of California the Alliance is known as CARA and yes, CARA is a Federal-government-oriented organization and Medicare and Social Security are also important elements in our public-service worker retirements.

The 2019 Arizona Legislature has completed its Legislative Session for the year and Chapter 101 is continuing its path toward legislative eBlasts of Arizona legislative proposals, as new retirees join our Chapter membership. The Friday morning meetings in Phoenix will most likely continue next year. Make a mental note and plan to attend then to learn about the proposed laws before the Arizona Legislature. RPEA Chapter Members are welcome to attend; bring any questions to ask about the proposed Bills. The RPEA Board pays membership dues to the Alliance, thus Chapter 101 members are eligible to attend as paid members of CARA with focus on Medicare, Social Security, Veteran

issues, Medicaid, and other important retiree issues. Following are the issues for this Legislative year 2019:

INFRASTRUCTURE, a Bill that will cost multi-Trillion Dollars.

CLIMATE CHANGE, a crisis that is due to human activity.

HEALTH CARE, making it a Right; Medicare; repeal of the 40% "Cadillac TAX" on health benefits.

MULTI-EMPLOYER PENSION PLAN Crisis - Insolvency projected in 20 years (5,400 Employers); stricter funding rules for employers. **IMMIGRATION** 

HEALTH & SAFETY, workplace violence prevention, et. al.

**ECONOMIC AGENDA:** Minimum Wage (\$15.00)

Health Families Act (paid sick days)

Family Act (paid family and medical leave)

#### PROXY SEASON - AGM (Annual General Meeting)

"Insolvency" of pension funds appears to be a growing issue these days. Several municipal employers who in the recent past have not paid their contribution into their employees' retirements is a lack of proper management of funds that they were to have held in trust for their employees. This is mis-management of funds - - a "promise" is very similar to a "contract".

When I learned of CalPERS' professional involvement, currently in "over 11,000 public companies", where "CalPERS has the right to cast a large number of votes" regarding an organization's operations, where CalPERS invests their (our) money, as a credible, honest, professional, and wise investor, I was elevated to a stronger opinion [ I will mention that until then I actually had no opinion about CalPERS except for being greatful that someone, i.e.; CalPERS, was investing and earning interest with the retirement contributions I paid from my paychecks ].

I am further captivated by their [CalPERS] Proxy Season article in the <u>Spring 2019 issue</u> of <u>PERSpective</u>; on "priorities during proxy season" (. . . AN EXCERPT):

We view our right to vote as a responsibility – one that we do not take lightly. As a long-term investor, having the abiliity to provide input to a company can help ensure that the company is run with a focus toward long-term sustainable returns."

#### MORE Social Security NEWS

A March 2019 Alliance article, "Social Security Fairness Act" S521 introduced by Senator Sherrod Brown and Rodney Davis repeals the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) which "claws back" workers and their spouses SS benefits, if they worked for a period of time in jobs not covered by SS; 25 percent of public employees nationwide, including millions of retired Federal, State, and local government employees who worked as teachers, police, firefighters, and general employees and their survivors, are affected by these provisions. The GPO has a particularly harsh affect on moderate-and-low-income pensioners, with women affected disproportionately and more likely to end life in poverty.

#### WE NEED YOUR "RSVP" for EACH Chapter MEETING!

No one from the Chapter replied to the inquiry article about our elected Federal Congressman speaking to Chapter 101, thus, we will <u>not</u> schedule-in this speaker. To appropriately honor and show respect and regard for our meeting speakers, we must have members at meetings where a speaker has been invited.

You Chapter members are making my position tasks very easy, but I am disappointed that we will not experience an update from our elected Congressman who represents Arizona and its citizens if not only to the other elected officials in Washington, D.C. nor will we hear what actually is being done and considered by our Country's elected law-makers.

We have 3 speakers scheduled at 3 of our 7 remaining meetings for this calendar year and if we are going to arrange meetings at restaurants, we must inform the owner/ manager of the number expected, at the least, so they can arrange the room to seat Chapter members together for a meeting--RSVP are needed.

#### Social Security NEWS

According to the Alliance May 2019 article, "Strengthening Social Security Act", Federal Representative Sanchez has on May 9, 2019, introduced Strengthening Social Security Act, HR 2654 – This legislation will strengthen the Social Security (SS) system while improving the economic and retirement security of millions of Americans .

For more than 80 years, SS has delivered its guaranteed benefits on time and without interruption. While SS's hard-earned benefits are modest, they are vitally important to all who rely on them, including seniors, people with disabilities, and families of deceased workers. Today over 62 million Americans (1 of every 4 households) rely on SS's lifetime guaranteed benefits.

One of several changes the Act includes is to delete the current cap on earnings subject to SS contributions which is \$132,900, over a 5-year period. This change alone extends the life of the SS Trust Fund through 2041.

Another-ensures widows/widowers 75% of the total household SS benefits they received prior to spouse's death.

#### NEW SOCIAL SECURITY CARDS

If you legally change your name because of marriage, divorce, court order or for any other reason, you must tell Social Security Administration so you can get a corrected card; no charge for this, but it's something you will have to do in-person or by mail. You cannot apply for a new card online. You will need proof of your identity. You may need to prove your current U.S. citizenship or lawful non-citizen status. The Community Service Project is "I-D'd": "Recycle Right"/"Re-Use"/Donate" and is for cell phones that are obsolete, useless-to-its-owner, and along with its components, are disassembled or prepared for re-use in a proper and ecologically safe manner.

The donated cell phones will be de-activated after arriving at a proper deactivation destination. Cell Phones can be gathered by a Chapter 101 Member (you can personally bring phones to our 11:30AM Chapter 101 Meeting on the 2<sup>nd</sup> Saturday of each month). We will forward phones to the proper de-activation destination..

The American CellPhone Drive.org will dispose of each cell phone by placing it into a donation box where it will be repaired and restored for additional use. If it is not then sellable, it will be broken down and recycled in accordance with State and Federal regulations which govern disposal of arsenic, lead, mercury, and other toxic cell-phone components.

Cell phones can be brought to a local donation-station drop-box, or mailed directly to the American Cell Phone Drive in quantities of 3 or more per mailed package if that is more convenient to you.

Gather up your old phones and bring them to the Chapter 20 year Celebration to contribute it/them to this worthwhile community service project.

The American CellPhoneDrive.org cell phone collection drives have also been used as school fundraisers to finance community recreation programs, and to provide working telephones and 911 service to At-Risk individuals such as indigent senior citizens who would otherwise be without phone service.

The organization raises funds for charitable organizations which provide scholarships for American children who have lost a parent to enemy or terrorist acts; feed malnourished children in Asia,; build low-income housing; donate prepaid calling cards to military personnel; sponsor missionaries in China; and support many other good works.


