This will be my report of the RPEA Biennial GA (General Assembly) (since its cancellation in 2020). GA was held at the Sacramento Hilton-Arden West hotel and it was a truly enlightening and enriching GA experience. Sixty-two RPÉA Delegate members were present to conduct RPEA business, our 9 AREA Directors met, we elected the next two-year's RPEA State Association Board of Directors, we voted down the two Resolutions brought before the Delegates. Social events included a few die-hards dancing the night away after the Banquet Dinner, a Delegates Reception, a Candidates Reception, Breakfast & Lunch Buffets, and Boxed Lunches sent home after adjournment. We had legislative status updates by our Lobbyists Aaron Read and Mr. Pat Moran, the Sacramento Mayor Eric Guerra spoke, and the VFW Post #8358 Honor Guard under Captain Michael Wong, Presented the Colors and led the reciting the Pledge of Allegiance to the Flag which solemnized the occasion, all this under the guidance of our longtime GA Parliamentarian Ms. Dollie McPartlin.

The Honorable John Garamendi, United States Congressman since 1974 was our Keynote Speaker; AMBA (Association Member Benefits Assn.) Regional Vice President Jack Danielson attended and led a workshop; (CRS) - Californians for Retirement Security representative Steve Maviglio, sat on the GA Legislative Panel (California State Senator Dave Cortese, supporter of the newly signed law SB1148 that increases the CalPERS member death benefit from \$500 to \$2,000, signed 9/26/2022) was invited but he was unable to attend.

All Chapter members' involvement and participation will keep the RPEA State Association Board of Directors informed of retirement issues that need attention.

2022 January 1st marked CalPERS' 90th Birthday. Originally known as the State Employees' Retirement System (SERS), CalPERS began operating in 1932 with 14,000 members.

By 1946, that number had more than tripled and today stands at 2 Million members.

In fiscal year 2021, CalPERS paid out more than \$27 Billion in pension benefits and \$10 Billion in healthcare benefits. The size of the sound investments of CalPERS means CalPERS will be here for a long time to come.
