Source: Washington, D.C. Admission Act, HR 51 - Del. Eleanor Holmes Norton, D-DC

There are 141,514 actively working Federal employees in the District of Columbia (many of whom live there, in Washington, D.C.). There are 44,014 residents who are Federal annuitants (retired). None of these residents had voting representation in Congress.

The Washington, D.C. House of Representatives passed the Bill in June 2020; this is the first time Statehood legislation has ever passed a chamber of Congress. However, the Senate was not expected to take up the Bill.

When the Bill became law, the District of Columbia became the 51st State with a new name: "Washington, Douglass Commonwealth" (D.C.). The change would grant the city's 700,000-plus citizens their local governance control, with votes in their "State" representation of: 2 Senators and 1 Representative.

An area surrounding the National Mall and Capitol Hill will serve as the seat of power of the Federal government.


→ RPEA 2020 GENERAL ASSEMBLY (GA)

As of 2/12/2021 CalPERS paid out \$25.8 Billion in benefits to more than 732,000 retirees and their beneficiaries.

The Hatch Act restricts "Partisan Political Activity", like using an official position to influence an election, Legislative advocacy (contacting a lawmaker about a Bill isn't political activity and is not prohibited by the Hatch Act). However, as a rule of thumb, Federal employees should engage in Legislative advocacy only on their own time and from their own devices or accounts. While it's not a violation, "Feds" should not advocate while on government time or using government resources.

Why A Cooking Co-op?

What it's worth: "Every Tuesday night, I cook dinner for three families besides my own, which is about 18 to 20 people."

I deliver it to their door and sometimes they stop by my house to pick-up their meals for the evening on their way home from work."

The average household spent \$6,133 per year on food in 2007 [the most recent year for which data are available from the U.S. Bureau of Labor Statistics] . . . \$3,465 on groceries and \$2,668 on meals away from home [that's almost \$300 per month for groceries and \$222.33 for meals away from home).

The Cooking Co-op suspects food prices soared in 2008, but let's use these numbers anyway. Assuming that a co-op could reduce the grocery bill by half and lower restaurant expenses by, 60 percent (factoring in the occasional meal out), families could save \$3,333 per year by co-op-ing.

Would you like more brain power?

Cooking Light magazine shared some "trending content" from their "sister brand TIME" regarding a boost for Brain Power . . . in accordance with the "eat more veggies" Mantra of modern day, "Older adultls who reported regularly eating 1-2 servings a day of green leafy vegetables slowed their rate of ages-related cognitive decline. So much so, in fact, that they tested as if they were 11 years younger, says a recent study in the Journal, Neurology." [I'd venture to say it's worth making a change to improve my elderly unavoidable reduced and reducing thinking power!]

CalPERS Long Term Care (LTC) Insurance Lawsuit

The "Long Term Care" class-action lawsuit, scheduled for trial in late March 2021 has, due to the Pandemic, been re-scheduled for September 2021.

In mid-November 2020, two CalPERS committees, the Investment, and the Pension & Health Benefits Committee, proposed to increase premiums: 52% in July 2021, and 25% in July 2022, totaling a 90% increase in premiums from current LTC premiums. We have been informed from CalPERS Stakeholder Strategy Manager, David Teykaerts, that some retirees who received a paper pension check for the month of June might have an issue with their bank not honoring or rejecting the check . . .

(See his message below).

If a member of Chapter 101 has one of these "rejected" checks, they should contact CalPERS at (888) 225-7377.

Valued Stakeholders [RPEA Local Chapter 101 Members] - -

I just learned about an issue that might affect some of RPEA Local Chapter members. Because of unknown at-the-time production/process troubles, the California State Controller's Office misprinted CalPERS June pension benefit checks for as many as 11,900 CalPERS retirees.

It seems there were discrepancies between in the numerical dollar figure on the check and the written-out words of the dollar value - - having worked at a bank myself in the past, most tellers looked at the dollar figure, not the written words on the line, so the vast majority of CalPERS checks will be cashed with no problem. But some retirees have reported that banks were not honoring the checks. Preferred Provider Organizations (PPO)

There is little that we know.

PERSCare will be renamed PERS Platinum. PERS Choice will transition to PERS Platinum to keep the broader network. PERS Select will be renamed PERS Gold. There is no information about what this means for rates but the stated purpose is to make the higher priced plan cheaper and the lower cost plan more expensive.

Health Maintenance Organizations (HMO)

This year CalPERS will risk-adjust the basic HMOs. The goal is to make the price more accurately represent the "value" staff assigns to the plans. Note: all the HMOs offer the same benefit designs; the difference is networks.

I have developed a table (attached to Mr. JelIncic's eMail . . . If you are interested in looking at the table, pls. contact him directly by telephone which is included above in the information header for this article) that shows the estimated adjustments. It is based on the 2021 prices since that is what is available. For Administrative Services I have used \$50 for all plans. The reason is that is the value CalPERS used in the example and I have no basis to make other choices. (I did ask over the weekend and will revise the chart if I get better information.)

I first developed the chart using the Adjusted MARA scores. I later added columns using the unadjusted score just to see what the results would have been if staff used the scores based on the data available.

Social Security FACTS

The Social Security Act was passed on August 14, 1935.

The Social Security Administration (SSA) provides financial security to 68 million retirees in the U.S.A.

A New WEP BILL —"Public Servants Protection and Fairness Act"— HR 2337, was introduced to Congress in April 2021 that would reform the Windfall Elimination Provision (WEP) and give "much-needed relief to the nearly two million people affected by it." [The WEP reduces the Social Security benefits of retirees who also worked in the public sector and did not contribute to Social Security during that time.]

Another proposed Bill would fully repeal the WEP and the GPO and is before Congress—HR 82—would repeal both the WEP AND the Government Pension Offset (GPO). Both Bills would bring relief to retirees who have been penalized by these two provisions for decades. HR 82 repeal legislation is the ideal solution, however, political and fiscal realities have prevented the it from advancing through the legislative process in the past. Both proposed Bills would bring relief to retirees who have been penalized for decades by both the WEP and the GPO provisions

Recently several RPEA members received invitation in the mail to join AFSCME (American Federation of State County and Municipal Employees) Retirees; it was in an somewhat official-looking green envelope.

[I have heard hype that they are some group of government managers, which should draw attention and respect automatically and did with me and I just assumed that like RPEA, not too many words have been heard about the AFSCME group. But when I received the mailed invitation, I definitely was curious about this "new group" of retirees until I read the word "Union". But when I read the word "Union" in their printed words, I stopped and felt a twinge, and then I read they were connected with CalPERS....]

AFSCME Retirees maybe new on the scene as (RPEA Director of Legislation has) [sic not] seen them at any SCORE meetings which is comprised of PERS retiree organizations such as Firefighters, Classified Employees, CHP, etc.

Research into AFSCME finds that former CalPERS Board Member Pryia Mathur is behind the new retiree group. She lost her election to Jason Perez a few years ago because some believed she was too closely tied to CalPERS Administration.
