### RENATO DE MORAES, OUTREACH EDUCATION COORDINATOR COUNCIL ON AGING – SOUTHERN CALIFORNIA

Mr. Renato de Moraes is originally from Sao Paulo, Brazil. He took up skateboarding as a youngster and became a professional in the sport in the year 2000, at the age of 19. He came to the U.S. in 2003, at the age of 22, intending to enhance his professional skateboarding career. He came alone with a room-mate, but no family members. He had bare-minimum English and no Spanish speaking skills (his native language is Portuguese). He realized that he needed skills in addition to skateboarding to earn a living in the U.S.

Renato attended Mt. San Antonio College to study English and Business Administration. He found employment with a law firm that specialized in Social Security Disability Claims and was with that firm for seven years. He worked closely with one of the firm's attorneys to learn all he could. That attorney eventually left the firm and in 2016,

#### PAST PRESIDENT'S MESSAGE.....

Hello Friends-We CalPERS retirees are facing an important task (as if we didn't already have enough on our minds). A special election will be held in fall, 2022, to fill the Retired Member seat on the CalPERS BOA that was vacated by Henry Jones in January, 2022. The winner of this special election will serve the remainder of the current term, as well as the next term of office through Jan. 15, 2028. Retired members are eligible to vote in this election.

Every CalPERS retiree should have received the CalPERS BOA's NOTICE OF ELECTION with instructions on the process of becoming a candidate. The nomination petition is due no later than May 12, 2022. From that date on, through August, 2022, expect to see campaign ads and videos by, respective, candidates. (I urge our members to view the Candidate's Forum, when it occurs-it is the best method of vetting the candidates in preparation for your own decision about which to support.) The election will occur in September, 2022.


